Greek anatomists were impressed by the observation that the pineal gland is an unpaired structure and they believed that it regulated the flow of thoughts philosopher Descartes proposed an important role for this organ in brain function. At the beginning of 20th century experiments by several investigators indicated that the pineal influenced sexual function skin pigmentation and was also responsive to light signals. With the isolation of melatonin from bovine pineal glands by Lerner and coworkers in 1958 the modern era of pineal research was initiated.
