

ENTERING GRENADA

A Traveler's Guide



This protocol can be changed at any time due to the uncertainty of the Corona 19 virus pandemic. Latest Update: 4th September 2020.

Grenada's colour code system represents low, medium and high-risk regions. The classification is based on the European Centre for Disease Prevention and Control - "**COVID-19 14-day case notification rate per 100,000 population**".

Please note that your travel status on entering Grenada is determined by the highest risk country that you have transited through or resided in during the fourteen days prior to entry.

Green Zone (Low Risk)

- All passengers are required to have a Negative PCR test result done within 7 days prior to arrival.
- Passengers whose travel-originated from the CARICOM bubble (Barbados, Dominica, St. Kitts & Nevis, St. Lucia, St. Vincent), and who were only residing in these countries for the previous 14 days, are currently exempted from this requirement.
- All passengers are required to present a completed health declaration form, a waiver of liability agreement form and a public health locator form upon arrival.
- The above may not apply to children 5 years and under, at the discretion of the Ministry of Health Official.
- **In the event that it is thought necessary to do a PCR Test on arrival, the passenger will be quarantined in a Government approved facility, at their expense, until the result is available and shows negative.**
- If the PCR test is positive, you will be rechecked in seven days.
- All PCR test and quarantining cost will be at the expense of the passenger. If a geofencing watch is required, the passenger will be required to pay for same. **(See Footnote).**

Yellow Zone (Medium Risk)

- All passengers are required to have a Negative PCR test, to be taken within 7 days prior to arrival.
- All passengers are required to present a completed health declaration form, a waiver of liability agreement form and a public health locator form upon arrival.
- All passengers will undergo a Covid19 PCR test on arrival at the airport.
- The above may not apply to children 5 years and under at the discretion of the Ministry of Health Official.
- If the PCR test is positive the person has to remain quarantined in the Government approved facility.
- All passengers will be required to spend a minimum of 10 days total in quarantine.
- There are two periods of quarantine, the first at a Government approved facility and the second self-quarantining at home.
 - All arriving passengers will have to be in quarantine at a Government approved facility for a minimum of two working days.
 - Passengers will have the option of spending the remainder of their mandatory 10 day quarantine period at a Government approved facility or be released to self-quarantine at home if approval is given.
- Persons willing to self-quarantine at home **MUST** first agree to the use of a geofencing watch for the remainder of the quarantine period.
- An official from the Ministry of Health will confirm exit from all quarantine.
- All PCR test and quarantining cost will be at the expense of the passenger. If a geofencing watch is required, the passenger will be required to pay for same. **(See Footnote)**.

Disclaimer: The Ministry of Health reserves the right to hold anyone in quarantine depending on their results and their clinical status.

Note:

- The use of the geofencing watch may not be applicable for persons below the age of 7.
- The cost of the geofencing watch is EC\$25.00 per person per day. A deposit of EC \$100.00 is required and will be refunded on return of the watch without evidence of tampering and in good working condition.

Red Zone (High Risk):

- All passengers are required to have a Negative PCR test, to be taken within 7 days prior to arrival.
- All passengers are required to present a completed health declaration form, a waiver of liability agreement form and a public health locator form upon arrival.
- All passengers will undergo a Covid19 PCR test on arrival at the airport.
- The above may not apply to children 5 years and under at the discretion of the Ministry of Health Official.
- If the PCR test is positive the person has to remain quarantined in the Government approved facility.
- All passengers will be required to spend a minimum of 14 days total in quarantine.
- There are two periods of quarantine, the first at a Government approved facility and the second self-quarantining at home.
 - All arriving passengers will have to be in quarantine at a Government approved facility for a minimum of 10 days.
 - Passengers will have the option of spending the remainder of their mandatory 14 day quarantine period at a Government approved facility or be released to self-quarantine at home if approval is given.

Red Zone (High Risk):

- All passengers will undergo a Covid19 rapid test prior to exit from the Government approved facility.
- Persons testing negative will be allowed to exit quarantine from the Government approved facility based on their agreement to wear a geofencing watch. (See below)
- Persons testing positive, will have a Covid19 PCR test and be released according to their result and the clinical assessment.
- Persons willing to self-quarantine at home **MUST** first agree to the use of a geofencing watch for the remainder of the quarantine period.
- An official from the Ministry of Health will confirm exit from all quarantine.
- All PCR test and quarantining cost will be at the expense of the passenger. If a geofencing watch is required, the passenger will be required to pay for same. **(See Footnote)**

- The use of the geofencing watch may not be applicable for persons below the age of 7.
- The cost of the geofencing watch is EC\$25.00 per person per day. A deposit of EC \$100.00 is required and will be refunded on return of the watch without evidence of tampering and in good working condition.
